## **Marine (Survey Fees) (Amendment) Regulations 2013**

IN exercise of the powers conferred upon me by sections 94(1) and 212 of the Marine Act 1986, I hereby make these Regulations—

*Short title and commencement*

1. These Regulations may be cited as the Marine (Survey Fees) (Amendment) Regulations 2013 and shall come into force on the date of its publication in the *Gazette*.

*Regulation 5 amended*

2. Regulation 5 of the Marine (Survey Fees) Regulations 1990 is amended by inserting after sub-regulation (2) the following new sub-regulation—

“(3) Sub regulation (2) shall not apply to a vessel under 10 gross tonnes.”

## **Marine (Coasting-Trade) (Amendment) Regulations 2013**

IN exercise of the powers conferred upon me under sections 158(1) and 212 of the Marine Act 1986, I hereby make these Regulations—

*Short title and commencement*

1. These Regulations may be cited as the Marine (Coasting-Trade) (Amendment) Regulations 2013 and shall come into force on the date of its publication in the *Gazette*.

*Regulation 5 amended*

2. Regulation 5 of the Marine (Coasting-Trade) Regulations 1990 is amended in sub-regulation (3) by deleting “\$50.00” and substituting “\$15.00”.

**Marine (Registration) (Amendment)  
Regulations 2013**

IN exercise of the powers conferred upon me by section 54 of the Marine Act 1986, I hereby make these Regulations—

*Short title and commencement*

1. These Regulations may be cited as the Marine (Registration) (Amendment) Regulations 2013 and shall come into force on the date of its publication in the *Gazette*.

*Regulation 19 Amended*

2. Regulation 19 of the Marine (Registration) Regulations 1990 is amended by deleting sub-regulation (2) and substituting with the following new sub-regulation (2)—

“(2) The fee payable on the registration of a vessel less than 100 gross tonnage is an amount calculated at the rate of \$0.25 for each gross ton of the vessel with a minimum fee of \$25.00 and for all other vessels, an amount calculated at a rate of \$1.00 for each gross ton of the vessel with a minimum fee of \$100.00.”

**Diplomatic Privileges (International Organisations)  
(Amendment) Order 2013**

*Short title and commencement*

1. This Order may be cited as the Diplomatic Privileges (International Organisations) (Amendment) Order 2013, and shall come into force on the 26th day of August 2013.

*Order Amended*

2. The Diplomatic Privileges (International Organisations) Order is hereby amended by inserting in the List—

“Pacific Islands Development Forum”.
